WHEREAS, on or about July 11, 2013, the New Lexington Education Association ("NLEA") appealed the grievance filed by teaching employee Doug Fehrman ("Fehrman Grievance") concerning his placement on the negotiated teacher salary schedule as contained in the negotiated Agreement between the NLEA and the New Lexington City School District Board of Education ("Board") (2010-2013), ("Negotiated Agreement") to arbitration before the Federal Mediation and Conciliation Service; and

WHEREAS, in an attempt to resolve with prejudice and formally settle any and all claims asserted in the Fehrman Grievance, the NLEA has worked by and through its representatives with official representatives of the Board to develop a Memorandum of Understanding ("MOU") that contains the terms of a global settlement; and

WHEREAS, the NLEA has approved the terms of the MOU as developed by the official representatives of the parties; and

WHEREAS the official representatives of the Board have presented the Board with the MOU and with a recommendation to approve its terms;

NOW, THEREFORE BE IT RESOLVED, that the New Lexington City School District Board of Education hereby approves the Memorandum of Understanding entered into by and between the NLEA and the Board containing a global settlement of any and all claims, with prejudice, as asserted in the grievance filed by Doug Fehrman concerning his placement on the negotiated teacher salary schedule as contained in the Negotiated Agreement between NLEA and the Board (2010-2013);

BE IT FURTHER RESOLVED, that the Board hereby authorizes its Treasurer to take any and all actions necessary to fully implement the terms of the Memorandum of Understanding forthwith.
