#### What is Schoolwide?

The schoolwide Title program enables both elementaries to have reading intervention from district reading teachers. The Title 1 reading teachers work with students who are identified as needing more help in reading. They also provide reading support to students' families through materials, training and communication. Schoolwide Title funding also provides for additional paraprofessional help. When available, Title funding is used to provide intervention materials and other supports in the Schoolwide buildings.

#### What is Title 1?
