Dear Parents,

New Lexington Schools is excited to announce that we have again partnered with the USDA to sponsor the federally funded Child and Adult Care Food Program. The Child and Adult Care Food Program (CACFP) provides meals and snacks to children at childcare centers, family day care homes, emergency shelters, and after-school programs, and to older or functionally impaired adults at adult day care centers.

Our program at NLSD will focus on providing free meals for our Employee Day Care Program at the Panther Cub Academy, as well as providing free snacks to our Pre-K enrollees at our Elementary Schools.

The other big aspect of our CACFP program will focus on offering free dinners on-site to any student in the district, including those attending after-school programs. The following sites will be utilized for dinner Monday through Thursday, starting September 9, 2024:

**New Lexington High School - 2:30 - 3:15pm**

**New Lexington Middle School - 2:30 - 3:15pm**

**New Lexington Elementary - 3:30 - 4:15pm**

**Junction City Elementary - 3:30 - 4:15pm**
